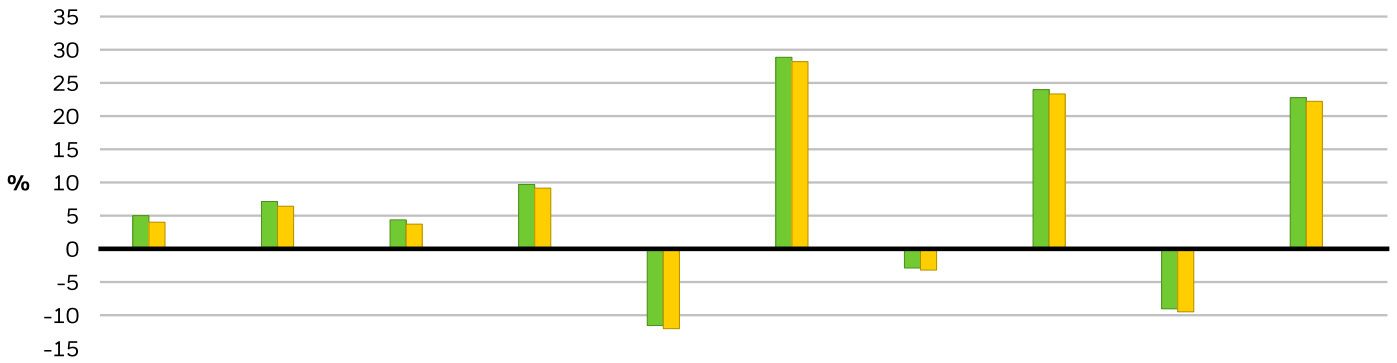

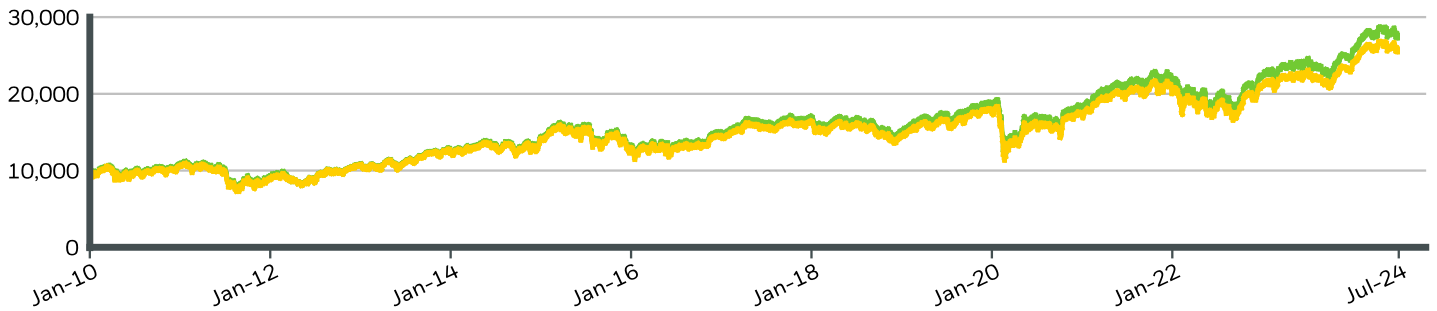

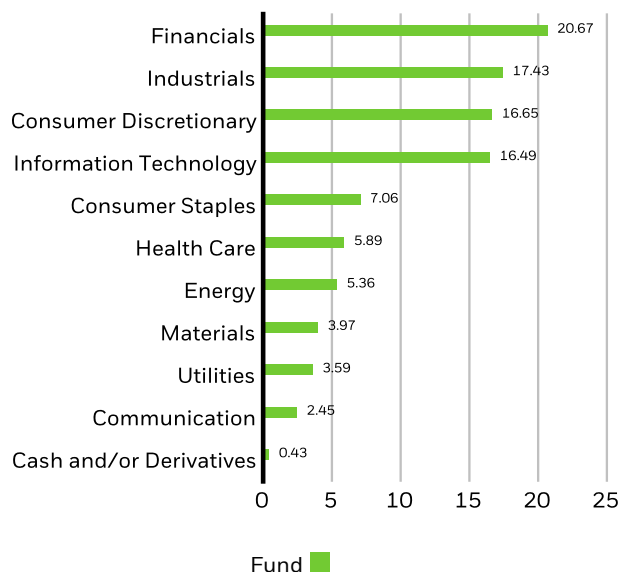

#### SECTOR BREAKDOWN (%)



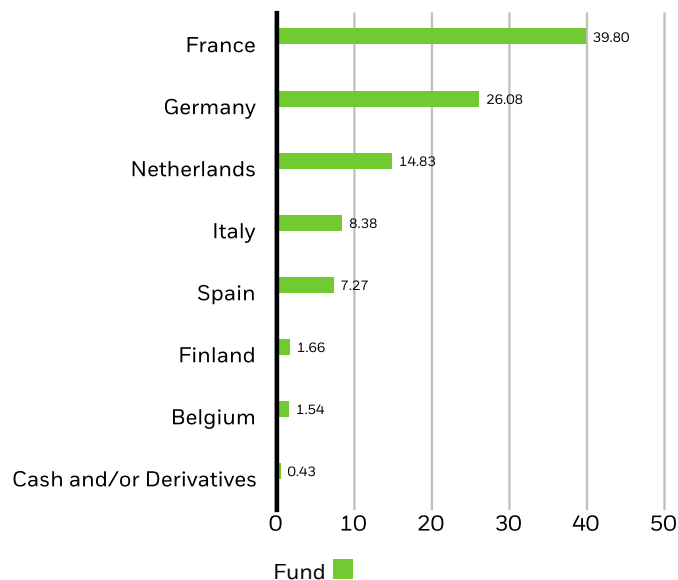
